

# Share Voting Report – Australian Equities Manager Holdings 1 January – 30 June 2013

#### Introduction


In accordance with our Active Ownership Policy, we seek to vote on all resolutions put forward at the meetings of companies held by Australian equities managers on our behalf and on behalf of our members.

In general, we vote in line with best practice guidelines including Australian Council for Superannuation Investors (ACSI) Governance Guidelines which seek to ensure that the Board of Directors of listed companies is accountable to and operates in the best interests of shareholders. Where we believe there is a potential conflict between the interests of the Board and our interests as a shareholder we will consult with our proxy voting adviser(s) and the equities manager(s) holding the shares on our behalf to assist us to determine the most appropriate way to vote.

This report provides a summary of how we voted on all resolutions put forward at all meetings of companies held on our behalf by Australian equities managers for the six months to 30 June 2013. Section 1 provides the summary statistics on the key categories on which we voted, highlighting those where we voted in opposition to the Board. Section 2 provides an alphabetical list of all the company meetings including how we voted on each individual resolution.

#### Section 1 – Summary voting statistics

During the reporting period we voted on 429 resolutions at 84 company meetings across a number of categories. Of total resolutions, 42 per cent related to director elections, 18 per cent remuneration proposals and 12 per cent capital or company structures and remuneration reports respectively.






### How HESTA voted

This table and the chart below show how HESTA voted within each of the key categories of resolutions.



#### Votes where HESTA opposed the Board

This chart shows the breakdown of votes where HESTA opposed the Board across the key categories. Just over half of the total votes opposing the Board related to remuneration proposals and just over a quarter related to directors elections.
