The additional money contributed to your super is one of the keys to saving for your retirement. If you are a HESTA member there are three ways to make extra after-tax contributions when it suits you.

## Contributions can be made by:

- 1. BPAY:** call us on 1800 813 327 or go to Member Online at [hesta.com.au/login](https://hesta.com.au/login) for your Biller Code and Reference Number.
- 2. Direct debit:** download a form at [hesta.com.au/directdebit](https://hesta.com.au/directdebit)
- 3. Cheque:** download and complete the deposit form on page 2 of this document and mail to us.

## Supplied your tax file number (TFN)?

If we don't have your TFN, we cannot accept extra personal contributions into your HESTA account. Provide your TFN online at [hesta.com.au/tfn](https://hesta.com.au/tfn) or call 1800 813 327.

## Instructions for completing your contribution deposit form for cheque payments

If you need advice on whether you're eligible for a tax deduction on your after-tax contributions, contact your financial planner, tax agent or the Australian Taxation Office helpline on 13 10 20.

1. Complete your details on the deposit form
2. Write your member number on the back of the cheque to ensure timely deposit to your account
3. Keep a record of your contribution by completing the payment record.
4. Mail your cheque and deposit form to HESTA.

The information you supply is required to accept your contribution and to help administer your account.

Your payment receipts will be shown on your annual statements. You can also access your account details anytime at Member Online at [hesta.com.au/login](https://hesta.com.au/login) or by calling 1800 813 327.
