# Search is on for Australia's community sector leaders

Nominations are now open for the 2018 HESTA Community Sector Awards, recognising people and organisations making exceptional contributions to social justice in Australia.

Presented by HESTA in partnership with the Australian Council of Social Service (ACOSS), the national Awards recognise excellence in service provision, advocacy and leadership in the community sector.

Anyone can nominate an individual or organisation with nominations closing on 03 August 2018.

HESTA CEO Debby Blakey said the Awards provide the chance to recognise the life-changing impact those working in the community sector have on supporting people and communities experiencing disadvantage.

"The Awards are an opportunity to highlight the amazing work of community sector organisations and individuals, whose work significantly improves the lives of others and helps build a stronger, fairer Australia," Ms Blakey said.

"Their work provides invaluable support to people who are often experiencing poverty, disadvantage and discrimination, I encourage anyone who knows a person or organisation making a difference to submit a nomination."
